THE PRIMARY SERVICE AREA IS MONTROSE, OURAY AND SAN MIGUEL COUNTIES. MONTROSE MEMORIAL HAD 2,725 ADMISSIONS FOR THE YEAR ENDING DECEMBER 31, 2015. MONTROSE MEMORIAL PROVIDES A SIGNIFICANT AMOUNT OF CHARITY CARE AND WROTE OFF \$3,493,570 IN CHARGES FOR THE YEAR ENDING DECEMBER 31, 2015.
